Important Notices:

A team must inform the host tournament no later than Monday (June 3rd) at midnight of the tournament week if they will not be able to attend. This will allow a waiting list team to be included in the tournament. Failure to abide by this rule will mean a one year suspension from state qualifier tournaments and the State Tournament per the state 7 on 7 rules. All deposit money will also be relinquished.

Don't forget your mouthpieces, you cannot participate without them! New this year is a recommendation to use soft shell helmets during SQT tournaments. They will be required at the State 7on7 Tournament should your team qualify.

Bring both white and dark colored jerseys. All jerseys must have numbers on front and back. The team listed first in the pairings will wear white, sit on the visitor side, and get the ball first. The second team listed will wear dark, sit on the home side, and get the ball after halftime.
